IN RE: Taser Problems

We have encountered a critical problem with our Tasers as follows:

1. The Tasers we have were purchased approximately 2005.
2. We have 5 Tasers that have gone completely inoperable.
3. We found that the Taser x24E is obsolete and is no longer manufactured by the company.
4. Taser International will not service or repair the Tasers that we have.
5. They have discontinued the sale of batteries or cartridges for the model we have.
6. Several of the remaining Tasers are now exhibiting problems that will soon render them inoperable.
7. Some of the units are at 30% which will cause them not to discharge.
8. This creates a danger to our officers as they will have no option in the use of force in serious hand to hand encounters with violent offenders or mentally challenged individuals.
9. O.C. spray is not a viable option because it always winds up on the officer and at times incapacitates the officer trying to effect arrest.
10. I have attached a quote from Taser for 24 Taser units, 30 batteries, and 78 cartridges which comes to \$ 33,104.19. We will also need \$ 1,200.00 for unit holsters.
