Chairman Dwight Purvis called the work session to order.

Daniel Barber – Road/Landfill Superintendent:

Road work detail.

- Tire Repair – Question regarding tires being stocked at Adel Tire & Recapping: According to Daniel Barber, Wilson recommended that tires not be stocked at Adel Tire & Recapping. Board instructed Mr. Barber to stock tires at Adel Tire to expedite tire repair and replacement. According to Mr. Barber, Nero Tire does the mounting for motorgrader tires, cheaper and more efficient.
- Beaver Control - Board discussed moving forward with Robert Browning's company for beaver control. Mr. Browning will be responsible for cleaning pipe out, breaking down dams, and maintain water flow continually, his cost will be \$60 per beaver.
- F350 Ford Fuel Truck – Daniel asked the board if the F350 fuel truck (262,000 miles) was to be repaired or if he should begin to look for a replacement truck. Board agreed to accept the quote from Highway Tire & Diesel, \$4,886.79 and \$190.00 for a six month warranty.
- Collection Sites- Daniel Barber reminded the board that he was waiting on another pulling truck and that the landfill had been pulling with one truck for 3 months. I believe with an additional truck it will help the overflow situation considerably. The board discussed manning the collection sites 6 days a week and leaving the drive through gates open at nights and on Sunday. Daniel stated that he believes that with 2 trucks running, the trailers will be emptied quicker and things will run much smoother. Ms. Darwin Eason and Mr. Joiner spoke to the board regarding keeping the collection sites open.
