GEORGIA UNIFIED CERTIFICATION PROGRAM – MEMORANDUM OF UNDERSTANDING: Commissioner Rowe moved to enter in the Memorandum of Understanding for the Georgia Unified Certification Program and authorize the County Administrator's endorsement, second Commissioner Robinson. Motion carried, 5 yes votes.

<u>BARNEYVILLE ROAD – RESURFACE/REPAIR</u>: Commissioner Robinson moved to ratify the decision to approve the estimated cost of \$25,000 to repair 300 feet of the Barneyville Road (east of the bridge between Cook and Berrien County), second Commissioner Parrish. Motion to ratify the decision carried unanimously.

<u>GEORGIA STATE PATROL RETREAT:</u> Commissioner Robinson moved to donate \$500 to assist in lodging expenses for the Georgia State Patrol's annual retreat, second Commissioner Lane. Motion carried unanimously.
