**Requested Repairs for Engine 21- Tony Oglesby** *First In Services, LLC, 4652 Rocky Ford Rd., Valdosta, Ga. 31601 (Tony's cell)229-460-1963* told me on the phone that he had gone over the truck at the Rd. Dept. last week. It will take \$1400- \$1500 parts, up to \$2000 with labor to repair the truck, the Board discussed last night. Mr. Oglesby said he could not guarantee the truck would pass a pump test them. The transfer valve and recharge valve are bad. He said he couldn't get the truck up to flow capacity let alone pass a pump test.
