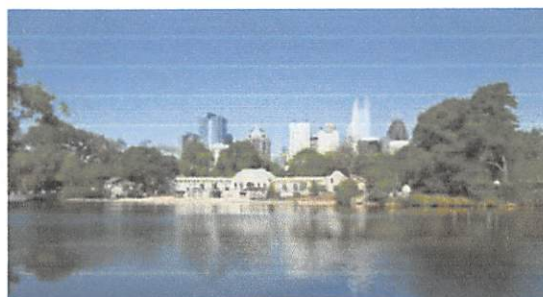
**ACCG's 2017 Legislative Leadership Conference focuses on issues important to you and your county!**
