Jess Permenter, Bldg/Zoning Administrator – RV Moratorium

FY2017-2018 BUDGET - Board reviewed proposed FY2017-18 Budget.

Daniel Barber – Road/Landfill Superintendent:

- Road department work detail was presented.
- Discussed repairs on the 2006 GMC Dump Truck, VIN 2598, transmission is currently being repaired at Highway Tire & Diesel with two year warranty, \$3,680.06 (if the core has to be replaced add'l charges will be \$1600.00) Board agreed to have repairs made.
- 7500 Chevrolet (over cab truck- pulls collection site trailer) Highway Tire & Diesel is checking it out, truck would only go 40 mph. No indication of what the issue could have been.
- New Tractor, Mower Prices were presented for an R Series John Deere (two steps ups from tractors we have ordered in the past).
