Chairman Purvis called the meeting to order.

Commissioner Rowe gave the Invocation.

Commission Board led the pledge to the flag.

MINUTES: Commissioner Robinson moved to approve the August 7, 2017 Work and Regular Session meeting minutes, second Commissioner Rowe. Motion carried, 5 yes votes.

Terri Jenkins, Red Cross- Executive Director: Ms. Jenkins gave a report of the participation of the Red Cross during the January tornados.

Larry Arnold – Chief Appraiser: Mr. Larry Arnold presented his request for an additional employee. Mr. Arnold's concern is that he does not have a staff member to assist with the personal property audit. The last audit cost was \$125,000 but rendered \$565,000. Mr. Arnold is requesting 1 staff member to aid in the audit and to help with the number of parcels that the county has currently salary approximately \$20,000 annually. According to his findings, Mr. Arnold is understaffed as to the ratio of parcels to employees.

No action was taken.

SURPLUS TRANSIT VEHICLE: Commissioner Lane moved to approve purchasing the surplus transit vehicle, DOT #3328, \$4500, second Commissioner Parrish. Motion carried unanimously.

Vehicle will be used by Cook Senior Citizen Center.

INTERGOVERNMENTAL AGREEMENT – TIFT COUNTY HOSPITAL AUTHORITY: Commissioner Rowe moved to authorize the Chairman's endorsement on the Intergovernmental Agreement with Tift County Hospital Authority, second Commissioner Parrish. Motion carried unanimously.

ACCG SAFETY DISCOUNT INCENTIVE – SAFETY COORDINATOR, INSURANCE CONTACT & HR LIAISON: Commissioner Parrish moved to reappoint Vicki Parrish as Safety Coordinator, Insurance Contact, and HR Liaison for the ACCG Safety Discount Incentive, second Commissioner Rowe. Motion carried unanimously.

LMIG RESURFACING SCORES: No action taken.

2017 LMIG STRIPLING PROJECT: Commissioner Rowe motioned to proceed with the bidding process for the 2017 LMIG Striping project, second Commissioner Parrish. Motion carried unanimously.

COURTHOUSE RENOVATIONS – DOORS: Commisioner Rowe moved to approve the invoice from Kelly Construction Co., \$2250, new doors and repairing doors for Probate and repairing doors for Superior Court, second Commissioner Parrish. Motion carried, 5 yes votes.

Executive Session: Commissioner Lane moved to enter into an executive session with the right to return to regular session, second Commissioner Parrish. Motion carried, 5 yes votes.

Commissioner Parrish moved to return to regular session, second Commissioner Lane. Motion carried unanimously.

Commissioner Lane moved to adjourn the meeting, second Commissioner Robinson. Motion carried unanimously.
