Chairman Dinnerman called the meeting to order and thanked the audience for their attendance.

Vicki Parrish gave the invocation.

The Commission Board led the Pledge to the American Flag.

**AGENDA ADDITION(S):** C. Funding –Summertime Safari  
D. Race Track Request for Time Extension

**TIM FLEMMING / SOUTH GEORGIA MOTORSPORTS PARK:** Tim Flemming requested extended times for upcoming races: September 25, 26, 27, October 31<sup>st</sup> and November 1<sup>st</sup>.

Commissioner Jeff Lane made the motion to approve a 1 hour extension on time (12:00 midnight) for races on Friday, September 26<sup>th</sup> and Saturday, September 27<sup>th</sup>, 2014 (Thursday, September 25<sup>th</sup>'s races will close at 10:00); the Board will review the time extension request for October 31 and November 1<sup>st</sup> at a later time, second Commissioner Randy Lane, 4 yes votes.

The above mentioned time extensions do not apply to the 3 overages granted by local ordinance; unless, the 10:00 o'clock curfew is broken on September 25<sup>th</sup> or the 12:00 o'clock curfew is broken on September 26<sup>th</sup> or 27<sup>th</sup>.

**EMPLOYEE HEALTH INSURANCE:** Commissioner Randy Lane made the motion ratifying the Board's motion concerning employee health insurance: county employees contribution will be \$30 biweekly for the low option plan and \$51.71 biweekly for the high option and the county will reimburse 50% of incurred charges up to the first \$3000 of deductible met, with a maximum of \$1500 per employee, second Commissioner Robinson, 4 yes votes.

New deductions will begin October 1, 2014; and, the above motion repeals all other motions regarding employee health insurance deductions and county contributions.

**TRAYLOR BUSINESS SERVICES:** Commissioner Jeff Lane made the motion to approve the contract with Traylor Business Services, personal property audits, second Commissioner Robinson, 4 yes votes.

**DISTRICT ATTORNEY'S REQUEST/ SUMMERTIME SAFARI FUNDING**: Commissioner Jeff Lane made the motion to approve \$500 for the circuit wide Summertime Safari for kid victims, second Commissioner Randy Lane, 4 yes votes.
