MOTORGRADER BIDS: Commissioner Robinson moved to approve the motorgrader bid from Flint Equipment Co. for a 670 G Motorgrader, \$201,000, 5 year/7500 Hour Buyback \$100,000, total cost \$ \$101,000., second Commissioner Rowe. Motion carried unanimously.

<u>2018 COUNTY CLERK APPOINTMENT</u>: Commissioner Rowe moved to reappoint Vicki Parrish as County Clerk for 2018, second Commissioner Parrish. Motion carried unanimously.

<u>SUPERIOR COURT RESOLUTION</u> - Commissioner Robinson moved to adopt the Superior Court Resolution designating the Cook County Sheriff's Office/Jail Enforcement Center courtroom as an official courtroom for any session or sitting of the Superior Court of Cook County, second Commissioner Parrish. Motion carried, 4 yes votes.

RESOLUTION

WHEREAS, Cook County, Georgia owns, has authority over and control of a courtroom facility which is connected to the Cook County Sheriff's Office; and,

WHEREAS, there is only one courtroom in the Cook County Courthouse; and,

WHEREAS, the courtroom connected to the Cook County Sheriff's Office has open public access, subject only to security screens; and,

WHEREAS, said courtroom has adequate space to accommodate a jury trial; and,

WHEREAS, said courtroom has adequate restroom facilities for the jury and the public to accommodate a jury trial; and,

WHEREAS, due to limited space for jury trials with only one courtroom, it appears to the governing authority of Cook County, Georgia that it is in the best interest of the public to have another courtroom available for jury trials,

NOW THEREFORE BE IT RESOLVED that the governing authority of Cook County, Georgia finds that the courtroom, which is connected to the Cook County Sheriff's Office, has public access, sufficient space and adequate restrooms to accommodate a jury trial.

FURTHER RESOLVED that the best interest of the public would be served by the furnishing of an additional facility for the holding of any session or sitting of Superior Court, including jury trials, which may be held from time to time.

FURTHER RESOLVED that pursuant to O.C.G.A. 15-6-18 the governing authority of Cook County, Georgia hereby authorizes that any session or sitting of the Superior Court of Cook County, Georgia, including jury trials, may be held in the courtroom facility which is connected to the Cook County Sheriff's Office.

FURTHER RESOLVED that the use of said courtroom for jury trials or other court proceedings shall be in the discretion of the judges of the Superior Court of Cook County, Georgia.

Resolution

WHEREAS, Cook County, Georgia is required by the laws of the State of Georgia to prepare, adopt and to operate under an annual balanced budget commencing October 1st of each Fiscal Year; and,

WHEREAS, the Board of County Commissioners has designated the County Administrator as the County Budget officer and has required the County Administrator to prepare and submit a balanced operating budget for Fiscal Year 2016-2017 for Cook County; and,

WHEREAS, the County Administrator presented a balanced Proposed 2016-2017 Operating Budget for Cook County at a scheduled public hearing to solicit public comments, as well as work sessions; and,

WHEREAS, the Cook County Commissioners adopted the proposed budget; and,

WHEREAS, any amendments to said Budget after Final Adoption shall be made as follows:

- Any increases in appropriation in any fund for any County Department of Cook County whether accomplished through a change in anticipated revenues in any fund or through a transfer of appropriations among Departments, shall require the approval of the Board of County Commissioners;
- Transfers to appropriations in any fund among the various accounts within a Department of Cook County, shall require only the approval of the Budget Officer, except that transfers of appropriations within a Department of Cook County which increases the salary appropriation shall require the approval of the Board of Commissioners; and,

WHEREAS, it has become necessary to amend the original budget; and,

WHEREAS, County Administrator has prepared the amendment and presented the proposed amendment to the Cook County Board of Commissioners for approval; and,

THEREFORE BE IT RESOLVED, the Board of County Commissioners hereby formally amend the 2016-2017 Operating Budget for Cook County as provided above.
