### **ACCG Refund Policy** *(adopted October 2015).*

The cancellation deadline is Thursday, March 29, 2018. Cancellations received in writing by this date will be entitled to a full refund less a \$50 administrative fee. Cancellations received in writing between March 30 and April 13, 2018 will be entitled to a 50% refund. There will be no refunds offered for cancellations received after April 13, 2018, unless the participant is able to substantiate a sound reason for the late notification such as an emergency beyond the participant's control in which case ACCG must be notified of the emergency within 7 days of the last day of the conference.
