<u>Minutes</u>: Commissioner Robinson moved to approve the December 4, 2017 minutes, second Commissioner Parrish. Motion carried with Commissioners Robinson, Parrish and Lane voting to approve. Commissioner Purvis and Rowe abstained from voting as they were not present for the December 4th meeting.

Commissioner Rowe moved to approve the December 28, 2017 meeting minutes, second Commissioner Purvis. Motion carried, 4 yes votes. Commission Lane abstained from voting as he was not present for the December 18th meeting.

JUNIOR MOORE LANE: Based on information provided regarding the property owner's health issues on Junior Moore Lane, Commissioner Parrish moved to approve the request from Dusty Moore to maintain his private drive, Junior More Lane. The county attorney will prepare an easement that will release the county of any liability and will release the county of future obligation should the property ever change ownership. Motion seconded by Commissioner Lane. Motion carried with 4 yes votes. Commissioner Rowe voted in opposition of the motion, stating that his feeling was not about a road, only private property.

<u>2018 CHAIRMAN</u>/ <u>VICE-CHAIRMAN</u>: Commissioner Lane moved to appoint Commissioner Robinson as chairman and Commissioner Parrish as vice chairman for 2018, second Commissioner Rowe. Motion carried unanimously.

<u>2018 COUNTY ATTORNEY</u>: Commissioner Rowe moved to appoint Daniel Connell as county attorney for 2018, second Commissioner Parrish. Motion carried, 5 yes votes.
