Chairman Purvis called the work session to order.

Aubrey Halstead - Compactor Specs - Mr. Halstead reviewed the specs for the compactor. The board added a 5 year/7500 guarantee buy back and a trade-in option to be included on the advertisement for bid.

Daniel Barber – Road/Landfill Superintendent: Mr. Barber presented the road work detail.

He informed the board that the tractor/mower ordered from Nashville Tractor (New Holland with Land Pride mower) is scheduled for delivery mid-February. (Purchased with USDA grant.)

Mr. Barber also discussed Wright Road, replacing pipe with retaining wall – it was decided to install new pipe.

Junior Moore Lane - The board discussed Mr. Dusty Moore's request for the county to maintain Junior Moore Lane. Mr. Moore's family's has medical necessity for ambulance service calls and the condition of the lane makes it difficult for an ambulance. The board discussed maintaining the lane with an easement until ownership of property changes.
