Sealed bids will be received by the Cook County Board of Commissioners in the Cook County Commissioners Office, until **10:00 a.m., local time, on May 25th, 2018**, at which time they will be publicly opened and read aloud for the following:

FURNISH MATERIALS, LABOR, TOOLS, EQUIPMENT AND APPURTENANCES NECESSARY FOR 8.03 MILES OF DOUBLE SURFACE TREATMENT STN SIZE 7 & 89, GP 2 ONLY, AND MISCELLANEOUS PATCH WORK ALONG NORTH UNION ROAD, MCCONNELL BRIDGE ROAD, QUILLIE JONES ROAD, LAKEVIEW CHURCH ROAD, AND EVERGREEN CHURCH ROAD. FURNISH MATERIALS, LABOR, TOOLS, EQUIPMENT AND APPURTENANCES NECESSARY FOR 8.98 MILES OF MISCELLANEOUS PATCH WORK ALONG HUTCHINSON PARRISH ROAD, COUNTY FARM ROAD, AND ROUNTREE BRIDGE ROAD IN COOK COUNTY, GA. Bids arriving after the designated time will be returned unopened.

No bids shall be withdrawn for a period of 60 days after the opening of bids. Cook County reserves the right to reject any or all bids and to overlook and/or disregard informalities or irregularities in the proposals.
