Subject: Dump Truck proposal Item Number: [Allen Crumbley Work Session Appt.](#)

For about two years now there has been an ongoing debate concerning the need for dump trucks at the Road Department. I have been in touch with Mr. Mark Thomas, who I believe Commissioner Parrish and Rowe may have met in Savannah. Mr. Thomas is the Mack Dealer in Tallahassee, Florida. His company has a lease program that leases or lease/purchases trucks to government entities.

We discussed their one year lease program. He has not given me definite numbers on the lease program, so I am a little hesitant to disclose those numbers in public right now. He did say they have no new trucks available right now.

They do, however; have two trucks that are coming back to them from Liberty County, FL after one year with less than 30,000 miles on them. They are fully equipped, ready to be operated. There are pictures attached. The trucks look new.

Also attached is the lease/purchase proposal for the two 2017 Mack Dump Trucks available by June 15, 2018. The purchase price is \$137,000 each. The lease purchase is for 5 years at an annual payment of \$60,206.20 per year total at the end of 5 years \$301,031. If we bought the trucks straight out the savings would be \$27,000.

If the Board were to choose to wait on trucks to be built, Mr. Thomas said it would take several months to get the bodies put on the trucks once they got the trucks themselves.

To lease the trucks a resolution would need to be adopted.
