#### **MENTAL HEALTH FORUM**

Dealing with individuals struggling with mental health and substance abuse issues is a growing concern for Georgia's counties. It is creating a financial burden on county services ranging from public safety and the courts to jails and public health providers. At the same time, it is a difficult issue for state and local leadership to address through legislation – and there is limited funding available to support or implement programs to help those in need. The ACCG Board of Managers created a Standing Committee on Mental Health which hosted a Mental Health Summit in August to help educate local government officials about how these issues are directly impacting your communities. Learn more about the next steps that are recommended from this committee, not only for the upcoming legislative session, but also by engaging and coordinating with your community stakeholders.

## **HOUSING AND YOUR LOCAL ECONOMY**

Tiny Houses ... Short-Term Rentals ... Abandoned Houses ... Affordable Housing. Housing issues like these have a tremendous impact on the success of your county's local economy, and it's important that your county is engaged in this area. Discover ways you can manage housing issues to improve the quality of life for your county's citizens.

#### **CHANGES COMING TO COUNTY REVENUES**

Several changes are coming to county revenues with internet sales tax, a new TAVT distribution formula, a new process for collecting E-911 fees, and adjustments to information available about local sales taxes. Georgia Department of Revenue Commissioner Lynne Riley and her staff lead the discussion during this session.

There are three conference hotels at Jekyll Island:

Hampton Inn and Suites (200 South Beachview Drive)

Standard guest rooms \$155 per night

Studio suites \$175 per night

In addition there is a \$5 per night hotel-motel fee and 11% tax.

## Jekyll Island Club Hotel (371 Riverview Drive)

Clubhouse and traditional rooms \$189 per night

Deluxe traditional rooms \$219 per night

In addition there is a \$15 daily resort fee, \$5 per night hotel-motel fee and 11% tax.

#### The Westin Jekyll Island (110 Ocean Way)

Island view rooms \$195 per night

Ocean view rooms \$225 per night

In addition there is a \$15 daily resort fee, \$5 per night hotel-motel fee and 11% tax
