CENTENNIAL CELEBRATION RESOLUTION

Celebrating the 100<sup>th</sup> anniversary of the Cook County, Georgia; and for other purposes.

WHEREAS, upon recommendation of the Georgia General Assembly in the summer of 1918, Cook County was created as the 153<sup>rd</sup> Georgia County. Created from Berrien County and named for General Phillip Cook, who fought in both the Seminole War and Civil War and was Georgia's Secretary of State for more than 20 years; and,

WHEREAS, the great County of Cook began its operations in 1919 after constitutional officers were elected, and

WHEREAS, the year 2019 marks the 100th year of its existence and, as such, Cook County, honors this illustrious milestone with a centennial celebration; and

WHEREAS, the 2018 Cook County Board of Commissioners, composed of Chair Debra Robinson, Vice-Chair Lindsey Parrish, Commissioners Jeff Lane, Audie Rowe, and Dwight Purvis recognize the significance of this celebration.

NOW, THEREFORE, BE IT RESOLVED that the Cook County Board of Commissioners hereby create the Cook County, GA Centennial Committee, and appoints residents from each county district to meet, as appropriate, and to organize events for this milestone year of recognition for Cook County.

BE IT FURTHER RESOLVED that the said members of the Cook County Board of Commissioners affix our signatures to this Centennial Resolution, and request that the Resolution be placed as a part of Cook County's official records to mark this year of this historic celebration.
