AUTHORIZATION TO ACCEPT GDOT CONTRACT <u>AP019-90ER-23(075)</u> PID-006707 FOR COSTS ASSOCIATED WITH Construction of Runway Extension AT THE COOK COUNTY AIRPORT

WHEREAS, COOK COUNTY desires to make improvements to existing Cook County Airport having solicited and receiving bids from the East Coast Asphalt and Engineering Services from Passero Associates, LLC for Engineering Design, and other Services and;

WHEREAS, COOK COUNTY will receive a contract from the Georgia Department of Transportation (GDOT) contract AP019-90ER-23(075) PID-006707 Cook County to provide reimbursement for the costs associated with the above noted Services up to a maximum amount of \$1,576,132.44 of which up to \$283,974 will be FAA Funds and up to \$1,292,158.44 will be State Funds and requiring a local match of approximately \$441,237.35 and;
