RESOLUTION

WHEREAS, Cook County and the cities of Adel, Sparks, Lenox and Cecil have met on Monday, September 17, 2018 to negotiate Local Option Sales & Use Tax Distribution; and,

WHEREAS, pursuant to an act of the Georgia General Assembly effective January 1, 1980 relating to Local Sales & Use Taxes, Cook County agrees that the distribution of the Local Option Sales & Use Tax will be as follows:

- City of ..... Adel shall receive..... 0.05%
- City of ..... Sparks shall receive..... 0.023%
- City of .....Lenox shall receive ..... 0.013 %
- City of .....Cecil shall receive ..... 0.004%
- County of .....Cook shall receive ..... 0.91%

NOW THEREFORE BE IT RESOLVED, this distribution formula shall continue in effect until such time as a new certificate shall be executed as provided in said Act this 1st day of October 2018.
