Flint Equipment -

Option #1 -2019 Bulldozer \$155,000, 5 year/6000 hours buyback of 65,000, Total cost after buyback \$90,000.

Option #2 – 2018 Bulldozer \$155,000, 5 years/6000-hour buyback, trade in 1992 D-5 Cat \$14,000, total cost of machine after buyback and trade in \$76,000.

Yancey Brothers Co. -

Option #1 – 2019 John Deere Bulldozer \$161,400, less 5 years/6000-hour buyback \$56,000, total cost of machine after buyback, \$105,400.

Option #1 – 2019 John Deere Bulldozer \$161,400, trade in 1992 D-6 Cat \$14,650, 5 years/6000-hour buyback \$56,000, total cost of machine after trade in and buyback, \$90,750.

Border Equipment -

Option #1 2019 Case Bulldozer \$158,108. No buyback offered.

Option #1 2019 Case Bulldozer \$158,108, trade in 1992 D-6 Cat \$19,000, no buyback offered, total cost of machine after trade in, \$139,108.

<u>City of Cecil – Mayor Spence and Councilmember Ben Pickett</u> asked the Commission to assist the City of Cecil in repairs needed on Old Coffee Road in the city limits.

<u>Centennial Committee</u> – Sharon Harnage presented the Commission with a proposed budget for the centennial committee. The committee also presented banners and items to be used for memorabilia for the centennial events.
