Subject: New Radio/Antenna System for 911 Item Number: VIII-B

Attached are two quotes from RCE of Valdosta for a new radio and phone system for 911. This will be replacing a system that has been in use since 2005 when the 911 building was completed.

Quotes are for the same equipment. New equipment costs will be \$310,000.00. RCE's fiscal year ends on March 31<sup>st</sup> and is offering a reduced amount of \$265,000 for the radio and phone system should the county commit to the purchase before the end of March, a savings of \$45,000.
