<u>MINUTES</u>: Commissioner Robinson made the motion to approve minutes from the January 22nd and February 8th meetings, second Commissioner Purvis. Motion carried unanimously.

<u>J. J. Strickland, Attorney at Law</u> - Mr. J.J. Strickland spoke to the Commission regarding supplements to the Superior Court Judges' salaries and presented a list of supplements paid in other circuits.

<u>19th HOLE AT CIRCLESTONE - 2019 ALCOHOLIC BEVERAGE APPLICATION</u>: Commissioner Lane moved to approve the 2019 Alcoholic Beverage Application presented by Nicholas E. Ekblaw, 19TH Hole at Circlestone, second Commissioner Robinson. Motion carried, 5 yes votes.

<u>RCE OF VALDOSTA - 911 PHONE & RADIO SYSTEM</u>: Commissioner Lane moved to accept the bid from RCE of Valdosta for a new phone and radio system for the 911 Center, \$265,000, second Commissioner Purvis. Motion carried unanimously.

<u>SHERIFF'S DEPARTMENT – SURPLUS PROPERTY:</u> Commissioner Lane moved to approve the Sheriff's Department surplus vehicles be assigned or sold as follows, second Commissioner Rowe. Motion approved by unanimous vote.

Assignment of the 2008 VIN #7658 and 3-2011 Crown Victoria's VIN's #1270, #1271 and VIN#1272, and 2013 Dodge Charge VIN# 9225 will be determined later.

EAST COAST ASPHALT, LLC CONTRACT – AIRPORT RUNWAY EXTENSION: Commissioner Purvis moved to approve the East Coast Asphalt, LLC contract for the airport runway extension project, second Commissioner Robinson. Motion carried by unanimous vote. <u>FIRE CHIEF POSITION</u>: Based on the recommendation from Scott Johnson, Excellence Exceeded, Commissioner Robinson moved to appoint John West as the County Fire Chief, second Commissioner Purvis. Motion carried, 5 yes votes.

<u>FEDERAL SAM PROGRAM – ENTITY REGISTRATION:</u> Commissioner Lane moved to authorize the Chairman's endorsement on the Federal Sam's Program Entity Registration, appointing Faye Hughes as Entity Administrator, second Commissioner Rowe. Motion carried by unanimous vote.

BARNEYVILLE ROAD RESURFACING– SCRUGGS COMPANY QUOTE: Commissioner Purvis moved to approve the revised quote of \$1,923,239.49 from Scruggs Company for Barneyville Road resurfacing, approximately 7.5 miles, second Commissioner Rowe. Motion carried by unanimous vote.

Additional cost of \$740,990.17 adds OGI & 12.5mm treatment to the resurfacing, extending the life of the resurfacing treatment to 20-25 years

<u>ROAD DEPARTMENT- LOWBOY TRAILER</u>: Commissioner Lane moved to accept the quote from Wallace Trailers, \$47,900, for a 35-ton Lowboy Trailer, second Commissioner Purvis. Motion carried, 5 yes votes.

<u>SHERIFF'S DEPARTMENT – ALL-TERRAIN VEHICLE & TRAILER</u>: Commissioner Rowe moved to accept the quote for an all-terrain vehicle for the Sheriff's Department, \$19,548.50 Valdosta Power Sports; and, \$1750.00 for a 14 ft double tandem trailer from Shiver's Utility Trailers, second Commissioner Purvis. Motion carried unanimously.

<u>SHERIFF'S DEPARTMENT- NEW TRUCK:</u> Commissioner Lane moved to accept the quote from Cook County Ford in the amount of \$30,885.00 for a new F150 that will be assigned to Sheriff Hanks, second Commissioner Rowe. Motion carried by unanimous vote.
