Again this year, Sheriff Doug Hanks is sponsoring the submission of the Department of Justice Community Office of Policing Services: School Violence Prevention Program (COPS SVPP) grant application. You may recall our efforts in 2018 in pursuit of this award program to provide funding to improve security at schools and on school grounds through evidence-based school safety programs. Wiregrass Georgia Technical College is pleased to offer the grant writing services for this project as part of our partnership with the Cook County Board of Education.


