Sealed bids will be received by the Cook County Board of Commissioners in the Cook County Commissioners Office, until **3:00 p.m., local time, on October 11, 2019**, at which time they will be publicly opened and read aloud for the following:

FURNISH MATERIALS, LABOR, TOOLS, EQUIPMENT AND APPURTENANCES AS NECESSARY FOR 0.80 MILES OF MILLING AND MIXING ASPHALT IN PLACE WITH 34 #/SY SOIL CEMENT, RESURFACING WITH 85 #/SY OF OPEN GRADED INTERLAYER LEVELING COURSE, AND 165 #/SY OF 12.5 MM SP APSHALT SURFACE COURSE FOR REED BINGHAM ROAD AND EVERGREEN CHURCH ROAD IN COOK COUNTY, GEORGIA. NECESSARY EROSION CONTROL PRACTICES, TRAFFIC CONTROL, PAVEMENT MARKINGS AND SIGNAGE WILL BE REQUIRED FOR THE PROJECT AS WELL.

All work on this project must be completed within 90 consecutive days from date of notice to proceed.

Bids shall be submitted on Bid Proposal Forms furnished for that purpose in accordance with the contract documents and specifications. No bid will be considered unless sealed and filed with Cook County prior to the time set forth above and accompanied by a Bid Bond, payable to Cook County, for 5 percent (5%) of the bid; to be forfeited as liquidated damages in the event that the bid be accepted and bidder fails to enter promptly into a written contract and furnish the required Payment Bond, Performance Bond, Insurance Certificates, and other required contract documents. Bids arriving after the designated time will be returned unopened.

No bids shall be withdrawn for a period of 60 days after the opening of bids. Cook County reserves the right to reject any or all bids and to overlook and/or disregard informalities or irregularities in the proposals.
