Chairman Lindsey Parrish called the meeting to order.

Commissioner Lane gave the invocation and the Commission led the pledge to the flag.

<u>MINUTES</u>: Commissioner Lane moved to adopt the meeting minutes from the July 15th meetings, second Commissioner Purvis. Motion carried unanimously.

<u>PUBLIC HEARING 2019-2020 General Fund Budget -</u> Commissioner Lane moved to enter into a public hearing with the right to return to regular session, second Commissioner Rowe. Motion carried.

There was no one present that spoke in favor or opposition of the budget.

Commissioner Purvis moved to close public hearing and return to regular session, second Commissioner Lane. Motion carried.

RESOLUTION – MEMORIALIZING OLD QUITMAN ROAD AS DAVE AND COMER KING JACKSON MEMORIAL ROAD: Commissioner Lane moved to adopt the Resolution memorializing Old Quitman Road as the Dave and Comer King Jackson Memorial Road and authorize Chair endorsing the same, second Commissioner Rowe. Motion carried unanimously.

# RESOLUTION MEMORIALIZING OLD QUITMAN ROAD AS DAVE AND COMER KING JACKSON MEMORIAL ROAD

Honoring the life and contributions of David "Dave" Edward Jackson and his wife, Comer King Jackson, and for other purposes.

WHEREAS, Dave was born to Stephen and Elizabeth Moore Jackson, who were married 21 Nov 1890, and Dave married Comer King, daughter of Jefferson King and his wife, Lydia Pennington; and

WHEREAS, Jefferson and Lydia King were probably born as slaves in the 1840s, married in 1870, five years after slavery ended, and reared 12 children, including Comer; and

WHEREAS, Comer and her parents lived on the Adel & Quitman Road, as noted in the 1910 Berrien County Census; and

WHEREAS, David Edward Jackson was born in 1891, and Comer King was born in 1895, and they were united in marriage by JJ Parrish in Berrien County, GA on 25 Feb 1912; and

WHEREAS, Dave and Comer reared several children in Cook County, stressing the value of education and hard work, with Old Quitman RD forming a boundary for part of their extensive property; and

WHEREAS, Comer was listed as a teacher, according to Cook County's first Federal Census, enumerated in 1920; and

WHEREAS, Comer walked over three miles to reach the rural school where she taught; and

WHEREAS, Dave and Comer were involved in farming, raising livestock, and interacting with both Black and White people in various agricultural enterprises; and

WHEREAS, Dave taught his children and grandchildren to have strong work ethics in a segregated South, and the Jacksons welcomed friends and those in need to partake of food at their kitchen table, regardless of race; and

WHEREAS, Dave built a prominent home on South Highway 41, and became a funeral director late in life; and

WHEREAS, Cook County, GA seeks to recognize noteworthy people during this Centennial year, and finds the Jackson and King families to be such; now

THEREFORE, BE IT RESOLVED that the approximate 6.02 miles of Old Quitman Road will hereafter be known as "Dave & Comer King Jackson Memorial Road," and that proper GA Department of Transportation signage will proclaim this designation.
