**MEMORANDUM OF UNDERSTANDING  
BETWEEN TOWN OF SPARKS AND COOK COUNTY, GEORGIA  
WITH APPROVAL BY SHERIFF DOUG HANKS**

This Agreement, entered into between Town of Sparks, Georgia and Cook County, Georgia, and with the express approval of Sheriff Doug Hanks, for the purpose of allowing Town of Sparks to continue to use the radio frequency (155.79000) that is licensed by the FCC to Cook County and assigned to the Cook County Sheriff's Office for public safety purposes within Cook County.

**WITNESSETH:**

WHEREAS, Cook County, Georgia possesses an FCC license and radio frequency (155.79000) that is assigned to the Cook County Sheriff's Office for purposes of public safety communications, and any other purpose allowed by law; and

WHEREAS, Town of Sparks, including Sparks Police Department, wishes to continue using such frequency for public safety purposes within Cook County; and,


WHEREAS, Cook County, with the approval of Sheriff Doug Hanks, hereby approves of Town of Sparks continued used of said radio frequency; and,
