Chairman Parrish called the work session to order.

Rusty McCranie - Road Superintendent updated the Board on the following -

- Wheeled excavator, according to Mr. Paul McSwain, Yancey Bros, 3 4 weeks out on mulching head and Caterpillar will take care of machine to be traveled to install. He has stated that with the thumb the machine will not operate without the out riggers stabilizing machine; or, installing a counter weight (Caterpillar will not warranty the machine with the counter weight).
- Mower max repaired at this time but no guarantee as to how long it will operate; next fail will require a new injector pump, estimated from Shiver Diesel of \$3300.
- 2000 Peterbilt Dump quotes for injector pump, Performance Peterbilt Tifton, \$4,824.23; Nacarator Truck Center \$5,348.20; Shiver Diesel \$5,618.99. Truck will be repaid by Performance Peterbilt for \$4,824.23.
- 2003 Volvo Dump- Cook County Welding has repaired a part in the read-end, projected cost of \$3000 to change over when it breaks down again.

<u>Chase Daughtrey, Probate Court</u> discussed upcoming contract with a new vendor for delinquent fine collection.

Sheriff Doug Hanks presented drawings for additional office space, evidence room, etc.

Fire Chief, Johnny West discussed volunteer fire personnel compensation.

<u>Daniel Barber</u>, <u>Landfill Superintendent</u> requested to move forward with advertising for a new landfill truck.

<u>November 18<sup>th</sup> Work Session</u> to include discussion of Solid Waste Collection and meeting with Yancey Bros regarding wheeled excavator mulching head.

<u>Dave and Comer King-Jackson Memorial Road</u> invitation to the dedication on Sunday November 20<sup>th</sup> at 3:00 p.m. Adel Church of God.

<u>2017 CDBG Project -Chaserville Mobile Home Park</u> completed under the projected cost by \$125,000, Commissioner Purvis and Larry Sanders and going to request funds to be used for

solar caution lights at the intersection at the Barneyville Road and Massee Post Road intersection. Funds are required to remain in the target area of the 2017 CDBG project.

Nell Purvis Road, Culvert Repair - An email from Larry Sanders stated that the size of the culvert is a sufficient size for the amount of water flow and is in good shape and doesn't need to be replaced. He further stated that there is a substantial water flow that is not properly directed in the direction of the creek so it has created a significiant scour hole, this issue could be corrected with the installation of rip rap as shown on the plans previsoulsy generated.
