Subject: VFD Extrication Tool Item Number: VIII-B

Commissioners,

The county fire department does not currently have extrication equipment (Jaws of Life). Over the past 9 months, there have been 7 calls where extrication equipment has been needed to assist with removing patients from vehicles. The City of Adel has been performing extrication for the past several years within the county and that continuously puts this shorthanded in the city while they are helping us.

We have submitted for a grant through Firehouse Subs for a complete set of equipment (Spreaders, Cutters, and Rams). If this is approved, it will be put in service after everyone is completely trained on the equipment.

The piece that we are talking about now is a combination tool. It's a spreader / cutter combined. This is a demo unit that is about a year old. Nothing is wrong with the unit and it has just been recertified. This unit can be put in any of the quick response units that we have, and it will give us the capability of a quicker response throughout the county. The new price on this unit is \$14,000. Since it is a demo unit, they are asking \$7,000 for it.

I have spoke with Sheriff Hanks, he has stated that he will assist with the cost of this unit. We have also been given a couple of donations totaling \$1,250 for the purchase of this jaws unit.
