Chairman Lane called the meeting to order. The pledge to the flag was led by the Commission.

MINUTES: Commissioner Robinson moved to adopt the meeting minutes as presented, second by Commissioner Parrish. Motion carried.

LANGUAGE ACCESS PLAN: Commissioner Purvis moved to adopt the Cook County Language Access Plan as presented for adoption by Southern Georgia Regional Commission, second Commissioner Robinson. Motion carried.

CECIL VFD- JODY MEELER: Commissioner Parrish made the motion to donate the \$3366.97 refunded to Cook County by Jody Meeler to the Cecil VFD's separate bank account. Mr. Meeler refunded salary earned in 2018 and 2019 - wages earned as volunteer conflicted with Mr. Meeler's Fireman's Pension Plan. Second by Commissioner Robinson. Motion carried with Commissioners Lane, Robinson and Parrish voting to approve motion. Commissioners Purvis and Rowe voted in opposition.

REAL PROPERTY PURCHASE & SALE AGREEMENT- SIXTEENTH STREET PROPERTY: Commissioner Purvis moved to Accept the Real Property Purchase and Sale Agreement presented by Peach Way Holding, LLC for 5.33 acres located off 16<sup>th</sup> Street, \$465,000. Second was made by Commissioner Parrish. Motion carried unanimously.

2020 LMIG: Commissioner Rowe moved to authorize the Chairman's endorsement on the 2020 LMIG correspondence and application for the 2020 LMIG funding of \$500,910, second Commissioner Purvis. Motion carried. 2020 LMIG will go back into the general fund to offset cost of resurfacing projects already completed.

MARSHALL LOCHER, BEAVER REMOVAL: Commissioner Parrish moved to enter into a contract for beaver removal services with Marshall Locher for a period of 6 months at the rate of \$900, second Commissioner Robinson. Motion carried unanimously.

If all parties are in agreement after 6 months, the services may continue until either party decides to terminate services with a 30 day written notice.

VFD – EXTRICATION EQUIPMENT: Commissioner Purvis moved to approve the purchase of the VFD Extrication equipment (\$7000) and fund the remainder funding of, \$3413.60 from the general fund contingency. Second by Commissioner Parrish. Motion carried
