EMPLOYEE HEALTH INSURANCE: Commissioner Lane moved to approve the renewal for county employee health insurance as proposed by Partners Benefit Group with an annual projected increase of \$46,839.78, second Commissioner Purvis. Motion carried unanimously.

Two plans will be offered from Anthem:

Option 1, Upper Plan – Premium for employee coverage \$856.89 with employees contributing \$92.61 per biweekly payroll (an increase of \$62.61 above current employee contributions.

Option 2, Basic Plan – Monthly Premium \$732.09 with employees contributing \$35.00 per biweekly payroll.
