Ms. Jessica Briones, 1123 Antioch Road, Adel, spoke to the Board in defense of her neighbors' allegations/complaints on she and her family. Documents were presented proving deputies answered 911 calls to the property with no charges filed or citations issued.

Mr. Dusty McCall, 95 Amber Court, Adel, stated that he had ask Mr. Boykin to contact him if anything is too loud. He also stated that he and his family are trying to follow guidelines as far music, pigs and dogs are concerned.

Mr. Carl Crosby, 1149 Antioch Road, Adel, stated he had been a neighbor of Ms. Briones and her family for years and have had no reason to complain about their music or any other issues.

Jess Permenter, Building/Zoning Administrator, stated that he had been to the property on Stevens Lane. The only findings that he was aware of, and that could be addressed by the county, was the location of the pens. Once, he told the property owner the proper set back rules, the pens were relocated. According, to Mr. Permenter, there were no findings.

County Administrator, Faye Hughes, stated that the only consideration the Commission was making was to review the nuisance ordinance. The Board would not be making any decisions with regards to issues presented by Mr. Boykin.

<u>LIBRARY ROAD:</u> Commissioner Purvis moved to reappoint Ms. Michele Siler and Ms. Eleanor Wright to the Cook County Library Board for a new 3-year term that will end June 2023, second Commissioner Parrish. Motion carried.

420E BACKHOE REPAIRS: Commissioner Parrish made a motion, seconded by Commissioner Purvis, that there was "no conclusive evidence" that work by Cook County Welding had damaged the 420E Backhoe Loader; and, Commissioners agreed for the County to pay a \$13,162 invoice from Yancey Bros. for repairs. Motion carried by unanimous vote.

EXECUTIVE SESSION: Commissioner Rowe moved to enter into an executive session with the right to return to regular session. Seconded by Commissioner Parrish. Motion carried.

Executive session was closed by motion of Commissioner Parrish and seconded by Commissioner Rowe. Motion carried.
