- Discussed discount pricing for the shop lift installation, with discounts final cost, \$11,150; 2 year warranty on jacks and 5 year warranty on the lift itself
- Mower Max a/c has been repaired.

- Board agreed to open hiring for the road department, hiring was suspended due to COVID-19.

- Boone Road and Howard Bennett Road, ditches haven't been pulled, machine is down for repairs.
- Commissioner Rowe mentioned a missing stop sign down at Old Union and Rountree-McCranie Road, Bill Rountree has been having issues with semi-trucks driving onto his property making the turn.
