<u>Landfill – All Terrain Vehicle:</u> From the bids presented during the work session by Daniel Barber, Landfill Superintendent, the Commission voted to accept the quote presented from John Deere for the John Deere HPX615E, \$10,2015 by motion of Commissioner Parrish and second of Commissioner Rowe. <u>PERU – Inmate Excess Medical Coverage</u>: Agenda item was tabled by motion of Commissioner Purvis and second of Commissioner Parrish.

<u>Airport Fencing Project - Passero Engineering</u>: Based on the Airport Authority's recommendation, Commissioner Rowe moved to accept the bid for the airport fencing project from McConnie Enterprises, \$109,807.96 and Passero Engineering's work order, \$36,058. Motion was seconded by Commissioner Purvis and carried unanimously.
