Chairman Lane called the work session to order.

<u>Brad Wente – Passero Engineering, Brent Dixon and Jerry Connell-Airport Authority Members:</u> Hanger Buildings D & E/ T-hanger buildings, 10 units total, approx. \$541,010. Mr. Dixon stated the authority would pursue a USDA loan to fund project. The authority currently has people on the waiting list to fill hangers. Proposal is for a design build bid.

Funding through the CARES Act allocation in the amount \$30,000, reimbursement grant. Possibly the fuel system upgrade could be reimbursed; fuel purchases reimbursement and, the purchase of a pull behind FOD, removes foreign objects and debris that collects on the runways.

Proposed projects - Precision Approach Path Indicator (PAPI) relocation, and Runway 23 Threshold. GDOT - FAA funding with the 75/25 matching funds. The relocation of Runway 23 is a safety issue and is being pushed by FAA. Work order for these projects are on the regular session.

<u>2020-2021 County Budgets and Other Entities</u> were presented by County Administrator Faye Hughes, total for upcoming budget year \$23,531,600.

Rusty McCranie, Road Superintendent - Presented work detail.

Wheeled Excavator - Mr. McCranie also discussed the possibility of purchasing heavy duty cutting head from Diamond Mowers that would be interchangeable with the mulching head on the wheeled excavator, 60" head that will cut up to 10 inches. Wheeled excavator will be able to cut, mulch or mow.

Commissioner Purvis – Maybe find county/city within 100 miles that has machine head that we could go look at.

Chairman Lane – suggested that maybe a better plan would be to sell the mower max to the City of Adel and buy a new side arm mower.
