Cook County School Board Resolution – Sales Tax Bonds, Series 2020 – Commissioner Parrish moved to adopt the *Resolution of the Board of Commissioners Providing for the Levy of Collection of an Annual Tax to Provide Funds for the Payment of the Principal and Interest of \$10,053,000 Aggregate Principal Amount of Cook County School District General Obligation Sales Tax Bonds, Series 2020*. Motion was seconded by Commissioner Rowe and passed unanimously.

Public Hearing: Commissioner Robinson moved to enter into a public hearing with the right to return to regular session. Motion was seconded by Commissioner Purvis. Motion carried.

Road Department – Fuel Trailer Purchase: The Commission Board approved the purchase of fuel trailer from Cook County Welding, \$3,000, by motion of Commissioner Purvis and second of Commissioner Parrish.
