- PPE is available and in storage
- AFG Covid-19 Grant application opening soon
- Continue to do weekly Pod Cast with Adel News

Hurricane Season – TS Delta could impact this weekend. GEMA has already created a weather event in WEBEoc. Weather updates starting as soon as tomorrow. If a shelter is required to be opened, it will be after the storm for county residents.

- Firehouse Subs presentation Saturday Morning at 10:00am at the 911 center.
- ISO process ongoing. We had to revise some paperwork, training rosters and call rosters
- RVF class, live burn (Nov 8th) and test date set (Nov 12th) This will add 8 certified Registered Volunteer firefighters to the roster
- Going tomorrow to pick up an F550 from Georgia Forestry. This truck will be built and used as a fast rescue truck for the extrication equipment.
- EMR Grant has been submitted
- Class in November for extrication equipment
