Chairman Rowe called the meeting to order and led the invocation.

The Commission led the pledge to the American flag.

Minutes were approved as presented by motion of Commissioner Parrish and second of Commissioner Purvis.

<u>2021 LMIG</u> - Commissioner Lane moved to accept the low bid from Scruggs \$1,438,127.21 for the following 2021 LMIG Road Projects - reconstruction of 1.25 miles of Ed Lindsey Road, reconstruction of 1.31 miles of Joiner Road, reconstruction of 0.2 miles of Burnette Road, reconstruction of 0.90 miles of County Farm Road, repair and restripe 1.45 miles of Springhill Road, repair various locations along Lonnie Grimsley Road, repair Greggs Road at Hwy 76, repair and stripe 4.1 miles of Rountree Bridge Road, repair Shady Grove Road and repair Hutchinson Parrish Road. Motion was seconded by Commissioner Parrish, carried unanimously.

Additional projects to be include - an additional mile of Ed Lindsey Road, Rountree Bridge Road resurface 1 mile, Hutchinson Parrish (Hwy 76 to Creek 1.2 miles) and Shady Grove Road .575 miles.

Alternate projects to be included if funding is available - Daniel Hesters Road and Hutchinson Parrish - additional mile (resurfacing to Cowart Cobb Road).

The other bid received for the 2021 LMIG projects - Reames Construction \$1,567,568.60

Resolution for Loan to Extend Hangars D & E, Cook County Airport: Commissioner Lane moved to adopt the Resolution for a Loan with Cook Community Bank for the purpose of Extending Hangars D & E at the Cook County Airport, in the amount of \$752,803.00. Motion carried unanimously by second of Commissioner Purvis.

<u>Southern Georgia Regional Commission Contract – Area Agency on Aging</u>: Commission Purvis moved to approve the Southern Georgia Regional Commission Contract for FY2022 to provide operation of a Senior Citizen Center with Congregate and Home Delivered Meals. Motion was seconded by Commissioner Robinson. Motion carried.

<u>Resolution – District Attorney Staff Salary/Benefits:</u> Commissioner Parrish moved to adopt the Resolution to offer all District Attorney staff the same benefit package. Motion carried by second of Commissioner Lane.

<u>Adel/Cook Land Bank</u>: Commissioner Purvis approved moving forward with the preparation of an Intergovernmental Agreement to establish the Adel/Cook Land Bank. Motion was seconded by Commissioner Parrish, motion carried unanimously.

Executive Session: Commissioner Lane moved to enter into an executive session with the right to return to regular session. Seconded by Commissioner Purvis. Motion carried.

Commissioner Purvis moved to close executive session and return to regular session. Motion carried unanimously by second of Commission Parrish.
