Chairman Rowe called the work session to order.

AmeriCorps Proclamation – Ms. Sidney Grant, requested adoption of the presented proclamation from AmeriCorps, proclaiming March 7<sup>th</sup>- 13<sup>th</sup> as National AmeriCorps week. The AmeriCorps organization assist the 4-H Club membership with youth development opportunities.

Rusty McCranie – Road Superintendent

- City of Cecil's request for assistant in patching a section on Fellowship Road at the lift station; the City of Cecil has agreed to pay the requested \$800. Also, the tree that the City asked to be taken down, hasn't been discussed again.
- Commissioner Lane asked about the bad spots on Fellowship at the Fiveash property, Mr. McCranie will take care of the issue when the other repairs are being done.
- Permission has been given to remove the large bushes on the corner of County Farm Road and Antioch, Mitchell property, property owners require that the fence be reinstalled once the process is complete.
- Commissioner Parrish asked for the road department to repair a bad place on Boyette Pond Road in front of the Boyette's shop; Commissioner Parrish requested to have the area cut out and repair the entire section to make it smoother.
- Rusty reported that he made contact with someone that could be interested in doing beaver control.
- Commissioner Lane asked that the mower max be used to trim the bushes/trees at the cut off road at the former Reames plant and in front of his shop on Bryant.
- Mr. McCranie advised the Board he would need to order more rock from Concrete Enterprise, \$23.50 per ton delivered.
