I am requesting to close the end portion of Livingway Rd. immediately past the property line of Open Door Church. It is the last 150 yards or so of the dead end road. I have purchased all of the land on both sides of the road past Open Door Missionary Church. Once past the church, the road dead ends into my house. I own everything on the west side of the road and directly behind the end of the road in mine and my wife's name. I own everything past the church on the east side of the road in my company name, BLH Development LLC. There would be no reason for anyone to go beyond the church drive way other than to come to my house. We have had issues with people coming to the end of the dirt road and driving onto my property and also I have seen trash that has been thrown out at the end of the road around my property. I am requesting that we be allowed to close the last section of the road so that we can put up a gate leading up to my house past the church for security reasons. Thank you for this consideration. 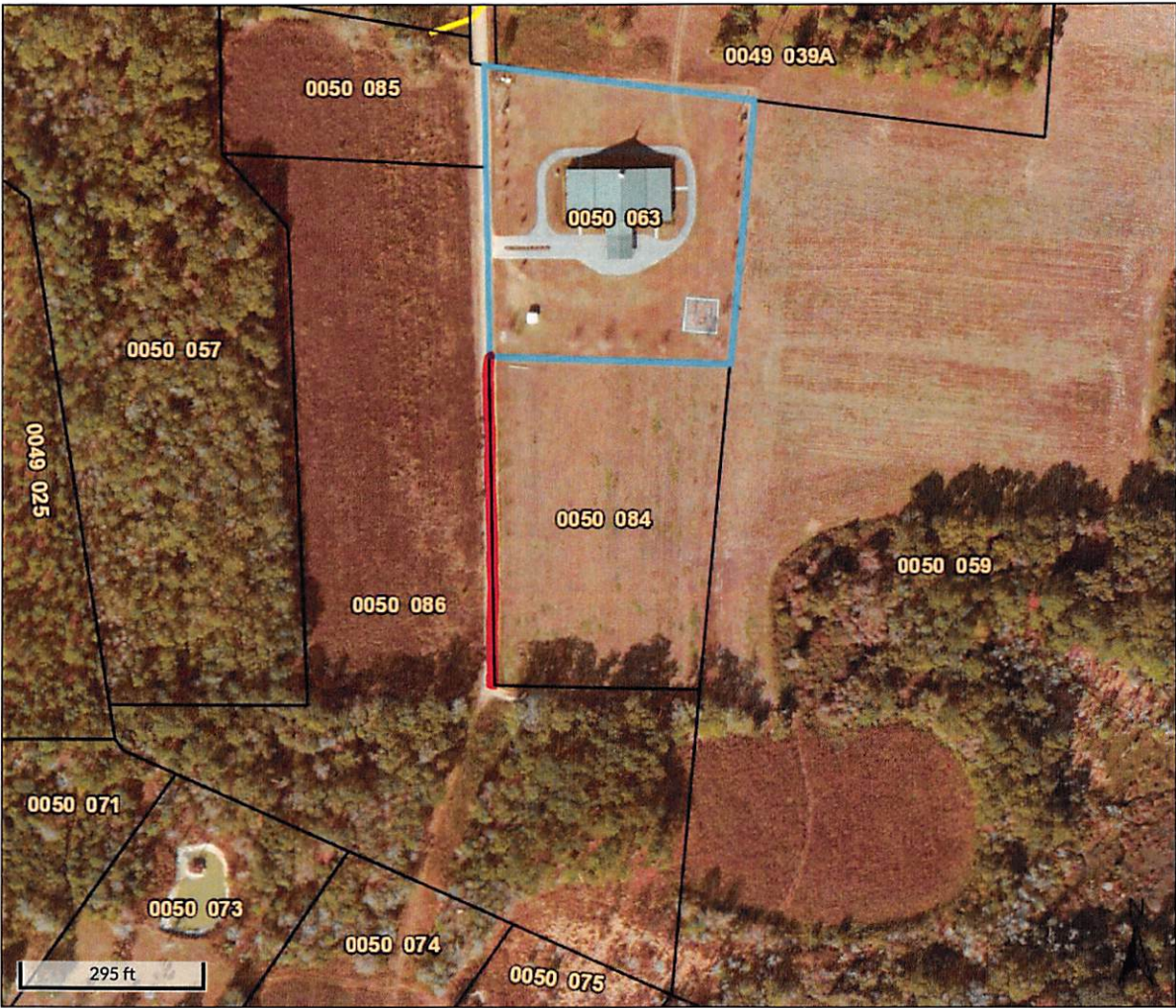
