Good morning Ms. Cowart and Mr. Hughes,

Our office has received a sponsorship letter from Representative Penny Houston for the redistricting of Cook County's shared Commission and Board of Education districts. I have received the requested addresses regarding the Commission and BOE members.

Attached are several .pdf's for your review.

- 1) CookCCSB-Draft1-2021-11x17: This is a minimal changes Draft1 map which balances the districts (with reasonable deviation). The districts were adjusted to bring their deviations as close to zero as possible, while remaining contiguous and compact. All incumbent Commission and Board of Education members were kept within their same districts. Efforts were made to keep voting precincts whole within the districts and minimize the total number of precinct splits. Any splits made were verified to not cause voter anonymity issues. An outline layer of the current districts (neon green) has been added for comparison to the proposed underlying
- 2) CookCCSB-Draft1-2021-Population Summary: This shows the numerical deviations of the proposed districts from the Draft1 map.
- 3) pop-summary-fields-explanation: This page explains/defines what each of the category headings mean on the Population Summary stat sheets.

If you would please review this info with all involved parties on your end, I would appreciate it.

### **Next Steps:**

If the Commission and BOE members are happy with the draft as is, the next step for you all is to check with your county's legal counsel as to what the public notice/comment procedures are if any and that if needed they are taken care of before the Boards formally approve the draft. Upon approvals of the draft, you will need to immediately inform your sponsoring legislator (Rep. Penny Houston) in writing (email attachment) of the Plan name (top right corner of the map). Please also copy/send said notice to our office as well. Upon receipt of your notice we will make ready said approved Plan for local legislation of the General Session come January.





# Local Redistricting Process Overview and Applicable Law

# **Local Redistricting Process Overview**

While there are many state and federal laws that impact the redistricting process (e.g., Voting Rights Act of 1965, Equal Protection Clause of the 14<sup>th</sup> Amendment, US and Georgia Constitutions, etc.), the following overview is limited to the local redistricting requirements provided for in O.C.G.A. § 28-1-14.1.

# **General Steps:**

- 1. Obtain a legislative sponsor in order to work with the Reapportionment Office and have that legislator notify the Reapportionment Office.
- 2. Determine if the maps for your county will be drawn by the Reapportionment Office, your GIS department, or another entity.
- 3. If your county draws its own map or uses an outside source, it must be technically reviewed and certified by the Reapportionment Office **BEFORE** it is adopted locally or it is submitted to your legislator to prepare legislation. Maps drawn by the Reapportionment Office do not need certification.
- 4. If your county draws its own map or uses outside sources, the map must be submitted in an <u>electronic format</u> with the following information to the Reapportionment Office (O.C.G.A. § 28-1-14.1(d)) for technical review:
  - A. Name, email, and telephone number of the contact person for the proposed plan
  - B. Name of the submitter and of the county, if different
  - C. Electronic map image that clearly shows defined boundaries and a block equivalency file containing two columns:

**<u>First Column:</u>** List the 15-digit census block ID numbers **<u>Second Column:</u>** List the 3-digit district identification number.

Both block and district numbers must be zero-filled text files and be submitted in .xls, .xlsx, .dbf, .txt, or .csv file formats

- D. Statistical plan information including the total population in each district and the population deviations of each district
- E. Additional information as required by Reapportionment Staff
- 5. If no technical issues are found during the technical review, the map will be certified and can be adopted locally. If there are issues, the map must either be corrected by the

Reapportionment Office or by the county/other entity. If it is corrected by the county/other entity, it must go back to the Reapportionment Office for review and certification.

6. Once the map has been certified, it can be adopted locally, and notification can be provided to your legislator to start drafting the legislation for introduction.



- 7. A local ad must run prior to the introduction of the legislation. Local ads can be run up to 60 days prior to legislative session and must run at least one calendar week prior to introduction of the legislation once session begins.
- 8. Local delegations may have special rules that apply to the passage of local legislation or specifically to redistricting legislation. Make sure you are aware of these requirements.
- 9. All maps for county commission districts must be passed by a local Act of the General Assembly and signed by the Governor, or become law without being signed by the Governor, to become effective.

Maps <u>are not</u> required to be precleared through the U.S. Department of Justice, unless they are covered by a separate court order entered into under Section 3(c) of the Voting Rights Act. Preclearance is no longer required due to the 2013 United States Supreme Court decision in *Shelby County v. Holder*, 133 S. Ct. 2612, which held it was unconstitutional to use the coverage formula in Section 4(b) of the Voting Rights Act to determine which jurisdictions are subject to the preclearance requirement of Section 5 of the Voting Rights Act.

# O.C.G.A. § 28-1-14.1

- (a) Except as provided in subsection (e) of this Code section, a local bill for revising the districts of county boards of commissioners, county boards of education, independent boards of education, or municipal governing authorities, or creating districts for such offices, shall not be considered by the General Assembly unless such bill meets the requirements of this Code section.
- (b) (1) A plan to revise districts or to create districts for existing offices contained in a local bill described in subsection (a) of this Code section shall either:
- (A) Be drawn by the staff of the Legislative and Congressional Reapportionment Office of the General Assembly; or
- **(B)** Be submitted to and certified by the Legislative and Congressional Reapportionment Office of the General Assembly prior to being adopted by the local governmental entity for whom such districts are to be revised or created in accordance with this Code section.
- (2) If a districting plan is to be drawn by the staff of the Legislative and Congressional Reapportionment Office of the General Assembly, the local governmental entity whose districts are to be revised or created shall contact a member of the General Assembly who represents such area in which such local governmental entity is located, either in whole or in part, and request that the member provide a letter of sponsorship, either in written or electronic format, directed to the Legislative and Congressional Reapportionment Office of the General Assembly, authorizing its staff to work with the representatives of such local governmental entity to prepare the districting plan. In lieu of authorizing representatives of the local governmental entity to work with such office, the member may work directly with the office in preparing the plan.
- (3) (A) If the local governmental entity chooses a source other than the staff of the Legislative and Congressional Reapportionment Office of the General Assembly to prepare a plan to revise its districts or to create districts, such local governmental entity shall, prior to voting to accept such plan, submit the plan to the Legislative and Congressional Reapportionment Office of the General Assembly for review. The local governmental entity shall obtain a sponsorship letter from a member of the General Assembly who represents that entity as provided in paragraph (2) of this subsection, authorizing the staff of the Legislative and Congressional Reapportionment Office of the General Assembly to review such plan. Upon receipt of such letter and the associated plan, the staff of the Legislative and Congressional Reapportionment Office of the General Assembly shall perform a technical review of the proposed plan to determine if the plan complies with federal and state constitutional requirements for such plans and the federal Voting Rights Act of 1965, as amended. Such office shall also review the plan to determine if such plan divides current voting precincts in a manner that could potentially compromise voter anonymity, leaves any geographic unassigned areas, maintains continuous geographic features, and any other concerns that such office may deem legally significant.

  (B) If the staff of the Legislative and Congressional Reapportionment Office of the General Assembly
- finds such plan to be technically sound, that office shall issue a certification form to the local governmental entity, which may then proceed to adopt the proposed plan for submission to the General Assembly for enactment. The staff of the Legislative and Congressional Reapportionment Office of the General Assembly shall prepare a legal description based on such plan for submission to the Office of Legislative Counsel for drafting the necessary legislation.
- (C) If the staff of the Legislative and Congressional Reapportionment Office of the General Assembly uncovers technical concerns in its review of the proposed plan, the staff shall notify the local governmental entity and the member who sponsored the review of the concerns. In light of the technical concerns uncovered in the review, the local governmental entity shall then have the option of either having the staff of the Legislative and Congressional Reapportionment Office of the General Assembly make the necessary corrections to the proposed plan and return it to the local governmental entity for approval for submission for legislation to be prepared by a member of the General Assembly who represents, in whole or in part, the area in which the local governmental entity is located, or it may have the original preparer revise it. If the original preparer is chosen to revise the plan, such plan shall be resubmitted for review by the staff of the Legislative and Congressional Reapportionment Office of the General Assembly in accordance with this Code section.
- (c) (1) A plan to create districts for a new municipality contained in a local bill described in subsection (a) of this Code section shall either:
- (A) Be drawn by the staff of the Legislative and Congressional Reapportionment Office of the General Assembly; or

- (B) Be submitted to and certified by the Legislative and Congressional Reapportionment Office of the General Assembly prior to being submitted to the Office of Legislative Counsel for drafting. (2) If a districting plan is to be drawn by the staff of the Legislative and Congressional Reapportionment Office of the General Assembly, the entity seeking to create the new municipality shall contact a member of the General Assembly and request that the member provide a letter of sponsorship, either in written or electronic format, directed to the Legislative and Congressional Reapportionment Office of the General Assembly, authorizing its staff to work with the representatives of such entity to prepare the districting plan. In lieu of authorizing representatives of the entity to work with such office, the member may work directly with the office in preparing the plan. (3) (A) If the entity seeking to create the new municipality chooses a source other than the staff of the Legislative and Congressional Reapportionment Office of the General Assembly to prepare a districting plan, such entity shall submit such plan to the Legislative and Congressional Reapportionment Office of the General Assembly for review. Such entity shall obtain a sponsorship letter from a member of the General Assembly as provided in paragraph (2) of this subsection, authorizing the staff of the Legislative and Congressional Reapportionment Office of the General Assembly to review such plan. Upon receipt of such letter and the associated plan, the staff of the Legislative and Congressional Reapportionment Office of the General Assembly shall perform a technical review of the proposed plan to determine if the plan complies with federal and state constitutional requirements for such plans and the federal Voting Rights Act of 1965, as amended. Such office shall also review the plan to determine if such plan divides current voting precincts in a manner that could potentially compromise voter anonymity, leaves any geographic unassigned areas, maintains continuous geographic features, and any other concerns that such office may deem legally significant.
- (B) If the staff of the Legislative and Congressional Reapportionment Office of the General Assembly finds such plan to be technically sound, that office shall issue a certification form to the entity seeking to create a new municipality, which may then proceed to submit such plan to the General Assembly for enactment. The staff of the Legislative and Congressional Reapportionment Office of the General Assembly shall prepare a legal description based on such plan for submission to the Office of Legislative Counsel for drafting the necessary legislation.
- (C) If the staff of the Legislative and Congressional Reapportionment Office of the General Assembly uncovers technical concerns in its review of the proposed plan, the staff shall notify the entity and the member who sponsored the review of the concerns. In light of the technical concerns uncovered in the review, the entity shall then have the option of either having the staff of the Legislative and Congressional Reapportionment Office of the General Assembly make the necessary corrections to the proposed plan and return it to the entity for submission to a member of the General Assembly for legislation to be prepared by the Office of Legislative Counsel, or it may have the original preparer revise it. If the original preparer is chosen to revise the plan, such plan shall be resubmitted for review by the staff of the Legislative and Congressional Reapportionment Office of the General Assembly in accordance with this Code section.
- (d) Proposed districting plans from a source other than the staff of the Legislative and Congressional Reapportionment Office of the General Assembly shall be submitted for review by such office in electronic format. Such submission shall contain:
- (1) Information regarding the contact person for the proposed plan, including email and telephone number;
- (2) The name of the submitter and the name of the local governmental entity that is the subject of the plan, if different;
- (3) An electronic map image that clearly depicts defined boundaries, utilizing the most recent United States census geographic boundaries, and a block equivalency file containing two columns. The first column shall list the 15-digit census block identification numbers, and the second column shall list the three-digit district identification number. Both block and district numbers shall be zero-filled text files. Such files shall be submitted in .xls, .xlsx, .dbf, .txt, or .csv file formats;
- (4) Statistical information on the plan which shall include, but not be limited to, the total population in each district and the population deviations of each district; and
- (5) Such other information as required by the staff of the Legislative and Congressional Reapportionment Office of the General Assembly.
- (e) If a member of the General Assembly desires to proceed with a local bill containing a districting plan which the Legislative and Congressional Reapportionment Office of the General Assembly has not certified, the member may do so only if a letter from such office is attached to the local bill when it is introduced in the General Assembly, stating that the bill cannot be certified by such office under this Code section and the reasons why.

# Local Ad Information and Redistricting Checklist

# Notice to Introduce Local Legislation: The simpler the better

A notice to introduce local legislation, also known as a local notice ad, requires no more information than the title of the bill. For a bill amending an existing local Act, the notice can merely cite the enabling statute creating the local governing authority and informs the public of the intention to amend such statute.

Below is an example of a local notice ad for a hypothetical bill amending a county's districting plan in the 2022 regular session:

NOTICE OF INTENTION TO INTRODUCE LOCAL LEGISLATION Notice is given that there will be introduced at the regular 2022 session of the General Assembly of Georgia a bill to amend an Act re-creating and establishing a Board of Commissioners of Barrow County, approved April 2, 1976 (Ga. L. 1976, p. 4033), as amended; and for other purposes.

The notice does not need to reference redistricting if such wording is not in the title of the Act being amended. Nor is there a requirement for a local notice ad to run under the signature of a member of the General Assembly or any other person. The example above represents all the information that is necessary for a proper local notice ad. The inclusion of more information in the ad could limit the scope of the legislation and even result in the notice being insufficient for the final bill, resulting in the need for re-advertisement, potentially delaying passage of the bill.

Local notice ads for redistricting bills can be put together by referencing the title of the last bill redistricting the particular jurisdiction. The above example ad is based on 2011's HB 9EX, Ga. L. 2011 Ex. Sess., p. 265. The title of this bill, with the relevant parts for the ad highlighted, is:

To amend an Act re-creating and establishing a Board of Commissioners of Barrow County, approved April 2, 1976 (Ga. L. 1976, p. 4033), as amended, particularly by an Act approved May 30, 2003 (Ga. L. 2003, p. 3889), so as to change the composition of the election districts from which the members of the Board of Commissioners of Barrow County are elected; to provide for implementation of such changes; to define certain terms; to provide for continuation in office of persons serving as members of the board on a certain date; to provide for the election and terms of members of the board; to provide for related matters; to provide for submission under the federal Voting Rights Act of 1965, as amended; to repeal conflicting laws; and for other purposes.

A local notice ad only needs to run once before the bill can be introduced. Ads can be run in the 60 days prior to the first day of the legislative session in which the bill will be introduced. If the ad runs during session, the bill cannot be introduced until the following calendar week, so running a proper ad early prevents potential delay in passage of a bill.

# **Frequently Asked Questions on Redistricting**

# Q: If my county uses a consultant or draws our maps in house, how long will it take the Reapportionment Office to certify our map?

A: This will depend on volume of maps submitted and the degree of mapping issues. Once your map has been submitted, it will enter the queue and will be reviewed in the order for which it has been submitted.

# Q: If my county challenges our census results, how will it impact our map?

A. While changes in population resulting from a challenge may impact funding formulas, it will not impact the mapping process.

# Q. Are local redistricting bills treated the same as general redistricting bills?

A. No. They are treated like local bills and will follow the same process as provided for other local legislation.

# Q. Can local redistricting bills be pre-filed?

A. No. Only general bills can be pre-filed. However local redistricting bills can be prepared by legislative counsel prior to the beginning of legislative session.

# Q: My county wants to work with the Reapportionment Office but cannot come to Atlanta. What can I do?

A: The Reapportionment Office can set up a virtual meeting or can answer questions by phone.

# Q: My county wants to draw our own map, but we may have questions. Can we contact the Reapportionment Office?

A: Yes. The Reapportionment Office can still provide assistance even if they are not drawing the map for your county.

Q: Can competing redistricting maps be introduced?

A: Yes.

Q: Does my county have to have the same legislative sponsor used to work with the Reapportionment Office as the bill sponsor?

A: No.

Q: Can redistricting legislation have a delayed start date?

A: Yes.

# Q: How much deviation should there be within districts?

A: The goal is zero. Arbitrary margins such as +/-5% should not be used. Advanced mapping technology allows for minimum deviation, so the goal should always be zero.

# Q: What is the deadline to submit a map to the General Assembly?

A: While there are no deadlines in federal or state law, counties should plan to do so as early in the legislative process as possible. Election staff needs to prepare for qualifying in early March as well as the May primary. Further, while not set forth in law, legislative delegations and/or bill sponsors may provide a timeline for counties to submit maps to be considered. Care should also be given to the amount of time needed for a map to be certified by the Reapportionment Office if the map submitted has been drawn by the county or consultant.

# Q: If the Reapportionment Office finds a problem with my map, who can fix it?

A: The Reapportionment Office can fix the problem, or it can go back to the county or consultant. However, if the Reapportionment Office fixes the problem, the certification is complete. Changes made by the county or the consultant must go back through the Reapportionment Office for certification which may prolong the process.

# Q: Can the board of commissioners and the school board have the same district lines?

A: Yes, however each entity must adopt their own map and have their map pass through the General Assembly as separate local Acts (i.e., the board of commissioners has a map, and the school board has a map).

# Q: Are boards of commissioners required to hold public hearings before maps can be adopted?

A: There are no requirements provided in state law, however there could be local policies and procedures that provide how redistricting maps are adopted in your county. Counties can choose to hold public hearings and to collect comments from public before adopting maps, but this is not a state law requirement.

# Q: Are there any examples of local resolutions for redistricting maps?

A: Yes. The following page includes a redistricting resolution from Carroll County.

RESOLUTION OF THE BOARD OF COMMISSIONERS OF CARROLL COUNTY, GEORGIA, APPROVING A REDISTRICTING PLAN FOR THE CARROLL COUNTY BOARD OF COMMISSIONERS, REQUESTING THAT ITS LOCAL LEGISLATIVE DELEGATION HAVE SUCH REDISTRICTING PLAN INTRODUCED AS LOCAL LEGISLATION AT THE 2022 REGULAR SESSION OF THE GEORGIA GENERAL ASSEMBLY, PROVIDING FOR AN EFFECTIVE DATE, AND FOR OTHER PURPOSES.

WHEREAS, the 2020 Decennial Census has been completed and the results thereof have been submitted to the Board of Commissioners of Carroll County, Georgia;

WHEREAS, such 2020 Census reflects that the population of Carroll County increased by 8,621 to 119,148;

WHEREAS, the County Commission Districts for elected members of the Carroll County Board of Commissioners must be redrawn in order to comply with federal and state guidelines, including the principle of "one person, one vote"; and

WHEREAS, Carroll County requested and obtained assistance preparing such redistricting plan from the Legislative and Congressional Reapportionment Office of the Georgia General Assembly; and

WHEREAS, the Board of Commissioners has considered public input on redistricting plans, and displayed the proposed plan at various public locations around Carroll County prior to the adoption of this resolution; and

WHEREAS, the Board of Commissioners desires to submit a proposed redistricting plan to its local legislative delegation to the Georgia General Assembly so that such redistricting plan can be approved by the General Assembly at its 2022 regular session and then signed by the Governor; and

WHEREAS, after considering public input, the principle of "one person, one vote", and other relevant matters, the Carroll County Board of Commissioners has determined the most appropriate redistricting plan for the Carroll County Commissioners and citizens of Carroll County;


NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners, acting in its capacity as the governing authority of Carroll County, as follows:

- (1) The Board of Commissioners hereby approves the redistricting plan attached as Exhibit "A".
- (2) The Board of Commissioners hereby requests that its local legislative delegation to the Georgia General Assembly draft and introduce during the 2022 regular session of the Georgia General Assembly such redistricting plan for passage by the Georgia General Assembly and signing by the Governor.


