Vice-Chairman Robinson called the meeting to order.

Commissioner Rowe led the group in prayer.

The Commission led the pledge to the American flag.

Commissioner Parrish moved to approve the minutes as presented. Motion was seconded by Commissioner Rowe. Motion carried unanimously.

Commissioner Parrish made a motion, seconded by Commissioner Lane; to accept the bid from Flint Equipment in the amount of \$691,690.00 for the Landfill Compactor that will be best suited for the needs of the Cook County Landfill. Motion carried, with all in favor.

Commissioner Rowe made a motion, seconded by Commissioner Lane; authorizing the County Administrator, Faye Hughes, to endorse the 2022-2023 Southern Ga. Area Agency on Aging Contract for the Senior Center. Motion carried unanimously.

Commissioner Parrish made the motion, seconded by Commissioner Lane; to accept the Timber Sale bid proposal from Canfor Southern Pine, and have the County Attorney prepare the contract. Motion carried unanimously.

Vice-Chairman Robinson made a motion, seconded by Commissioner Parrish to appoint Commissioner Audie Rowe as the Cook County voting delegate for the 2022-2023 ACCG Legislative Conference. Motion carried.

Commissioner Rowe made a motion, seconded by Commissioner Lane; to accept the Resurfacing bid proposal from The Scruggs Company in the amount of \$1,996,243.16, and to have the County Attorney prepare the contract. Motion carried unanimously.

Commissioner Parrish made a motion, seconded by Commissioner Rowe; to accept the Striping bid proposal from Peek in the amount of \$76,325.00. Motion carried unanimously.

Commissioner Lane made a motion, seconded by Commissioner Parrish; to sell two military trucks from the fire department for \$5000.00 Motion carried.

Commissioner Parrish made a motion, seconded by Commissioner Lane; to move forward with the additional Landfill Dirt Pan repairs, with the exception of the seat and heater valve replacements. Motion carried.

Commissioner Rowe made a motion, seconded by Commissioner Lane; to authorize Chairman Purvis' endorsement of the Windstream Broadband Build Agreement, for the amount of \$10,919,655.00 in Georgia State and Local Fiscal Recovery Fund Grants to enable Windstream to develop telecommunication facilities for community residents. Motion carried.

With all business concluded, Commissioner Rowe made a motion, seconded by Commissioner Parrish to adjourn the meeting. Motion carried.
