Sealed bids for the **REJUVENATE AND RE-MARK RUNWAY 5-23** project at the Cook County Airport, Adel, Georgia, will be received by the Cook County Board of Commissioners, until **2:00 P.M. EDT on Tuesday, November 29, 2022** at which time they will be publicly opened and read aloud in the Cook County Board of Commissioners Conference Room, 1200 South Hutchinson Avenue, Adel, GA 31620.

**PROJECT DESCRIPTION**

The construction of the rejuvenation and remarking for Runway 5-23, consisting of the rejuvenation of approximately 92,000 SY of asphalt, the remarking of the entire runway, and a 150-foot threshold displacement.
