Chairman Purvis called the Work Session to order.

#### Linda Weeks, Co-manager South Ga. Motorsports Park

Linda Weeks requested hours of operation, for the racetrack, be extended between 12am-1am on October 28<sup>th</sup> and 29<sup>th</sup>, 2022 for the *No Mercy* racetrack event. Chairman Purvis requested a written schedule of October races. County Attorney, Daniel Connell, clarified that for hours of operation to be changed; a public hearing would need to be held followed by an ordinance amendment. Commissioner Rowe made a motion, seconded by Commissioner Parrish to approve the special exception request for Mr. Glenn Reed. Motion carried unanimously.

Commissioner Parrish made a motion, seconded by Commissioner Rowe, for Cook County to partner with Windstream and host a townhall meeting. Motion carried unanimously.

Commissioner Lane made a motion, seconded by Commissioner Parrish to authorize the Chairman's endorsement of the Cook County Ga. Law Enforcement Center inmate medical insurance renewal application, presented by Greene Insurance Agency Inc. Motion carried, with all in favor.

Commissioner Lane made a motion, seconded by Commissioner Parrish to accept the proposal from Cowart Electric & Industrial Contractors, Inc. for the purchase of the Cook County Sheriff's Department Generator System in the amount of \$152,028.00 with an annual preventive maintenance cost of \$1600.00. Motion carried unanimously.

Commissioner Rowe made a motion seconded by Commissioner Lane to accept the low bid of \$ 968,182.39 from Griffin Grading & Concrete, as the Contractor for the Cook County CDBG project for Siska Lane and Harrell Road. Motion carried unanimously.

With all business concluded, Commissioner Lane moved to adjourn the meeting, motion was seconded by Commissioner Parrish. Motion carried.
