Chairman Purvis called the meeting to order.

Commissioner Rowe led the group in prayer.

The Commission led the pledge to the American flag.

Commissioner Robinson moved to adopt the minutes as presented. Motion was seconded by Commissioner Parrish. Motion carried, with all in favor.

Bill Twomey with ACCG, presented Chairman Purvis with an ACCG Lifelong Learning Academy Specialty Track Certificate, for his continued participation in the Board of Commissioners training curriculum.

Chas Cannon, Colquitt County Administrator

Chas Cannon asked the Board of Commissioners to consider a partnership what would allow Colquitt County to utilize Cook County's landfill. Currently, Colquitt County has a transfer station but no county landfill.

Motions:

Commissioner Parrish made a motion, seconded by Commissioner Robinson, to reappoint Stephen Wood to the Board of Assessors for the term January 1st, 2023-December 31st, 2026. Motion carried unanimously.

Commissioner Lane made a motion, seconded by Commissioner Rowe, to authorize Chairman Purvis endorse a tax release application that would refund Mr. Vikram (Rocky) Patel \$804.51 for square footage property taxes that were miscalculated during 2019, 2020, and 2021. Motion carried unanimously.

Commissioner Parrish made a motion, seconded by Commissioner Robinson, to appoint Rhonda Bennett as District 1 and Ray Greeson as District 2 representatives to serve on the

Board of Elections and Registration for the term January 1st, 2023-December 31st,2026. Motion carried unanimously.

Commissioner Parrish made a motion, seconded by Commissioner Rowe, to approve the installation of lighting by American Lighting and Signalization, LLC at the intersection of Hutchinson Parrish and Cox Still Road, for \$46,677.18. Motion carried unanimously.

Commissioner Lane moved to authorize County Administrator, Faye Hughes, reimburse the general fund for the American Lighting and Signalization, LLC light installation at the intersection of Hutchinson Parrish and Cox Still Road, with SPLOST funds when allocated. Commissioner Parrish seconded the motion. Motion carried unanimously.

With all business concluded, Commissioner Rowe moved to adjourn the meeting, motion was seconded by Commissioner Parrish. Motion carried. The meeting adjourned.
